General Rule: If the website contains data or evidence essential to a point being addressed, it should be formally cited with the URL and date of access.	
Examples:	
Retrieved from an Institution with a known location	Author. Year. "Title." Location: Publisher. Retrieved Date (URL). American Sociological Association. 2006. "Status Committees." Washington, DC: American Sociological Association. Retrieved July 11, 2010 (http://www.asanet.org/about/committees.cfm).
Report Published and Retrieved from a University Website	Author. Year. Report Title. Location: Publisher. Retrieved Date (URL). John Hopkins University. 2003. <i>Economic Impact of the John Hopkins Institutions in Maryland</i> . Silver Spring, MD: John Hopkins University and John Hopkins Medicine. <p>ASA follows the author-date system of citation in <i>The Chicago Manual of Style</i> (2003) which includes a brief text citation (enclosed in parenthesis) and a complete list of references cited (included at the end of an article, before any appendices).</p>
